### **WELCOME REMARKS:**

Chairman Alan Rindlisbacher welcomed everyone to the 4th Quarter Board of Trustees Meeting held at The Falls Event Center at Trolley Square and thanked the attendees for coming. This could not be done without community support, and that support is represented by the many people in attendance.

## APPROVAL OF THIRD QUARTER BOARD OF TRUSTEES MEETING MINUTES:

Chairman Rindlisbacher mentioned that the minutes of the 3rd Quarter Board of Trustees & Membership Meeting / President's Forum, held September 24, 2015, were distributed to the board members. There being no corrections or changes, on motion of Neil Wilkinson and seconded by Erik Christiansen, the minutes were unanimously approved.

### SALT LAKE COUNTY REMARKS:

Deputy Mayor of Salt Lake County, Lori Bays, thanked the partners and private businesses working together to advance the local economy. Deputy Mayor Bays recognized 2015 as a benchmark year in tourism, surpassing the 2002 Olympic Games in hotel room goals. Salt Lake County government looks forward to hosting the American Society of Association Executives in August of 2016. In addition, Salt Lake County is moving forward with the building of a convention center hotel, and the RFP will be closing on December 18th, 2015.

## 2016 TRUSTEES/OFFICERS ELECTION:

Past-Chair Kevin Bruder mentioned that Visit Salt Lake is an association of more than (700) companies and individuals. It's at this meeting that we elect one-third of our Board for a three-year term, and additional nominees are elected to fill vacancies. ## Call for motion to elect the Executive Committee Officers for 2015:

Karen Hale motioned the call and Arlyn Bradshaw seconded. The motion passed unanimously.

<u>UTAH OFFICE OF TOURISM PRESENTATION:</u> Vicki Varela, a great partner of VSL, gave a presentation on UOT's year-end update:

- 2015 Highlights:
  - o Fodor's Travel Guide selected Utah as the Travel Destination of the Year.
    - Tourists are now spending \$1.07 Billion yearly.
    - Governor Herbert has challenged UOT to increase tourism spend to \$1.2 Billion by year
  - The "Find Your Greatest" television ads were very successful in 2015, featuring six Utah individuals, each personalizing their experiences on "the Greatest Snow on Earth". Ads were shown in Los Angeles, San Diego and New York.
    - Since the campaign started, consumer's time spent on the website has more than doubled.
  - Utah Office of Tourism will be partnering with Visit Salt Lake to host American Society of Association Executives, participating with a \$75,000 donation.
  - Visit Salt Lake and Utah Office of Tourism Partnership involves the following:
    - Building an "urban" brand for Salt Lake
    - **Expanding International Marketing** 
      - For the second year, the state of Utah combined with local partners, to create a very sophisticated international marketing strategy with Brand USA.
    - 2016 is the year of the Chinese Traveler.
      - 2,000+ Chinese tour busses visited Temple Square last year.

- Chinese tourists grew to be the second largest in international tourism spending in 2016.
- There is now a Utah Office of Tourism representative located in China.
- Invested \$383,000 in Visit Salt Lake's efforts, including promotion of Ski City.
- Salt Lake City was recognized in 2015 in multiple food and dining publications.
- "Mighty 5" campaign continued to be successful in 2015.
  - Campaign will be updated this spring, as we continue to air the current version now on cable television.
- Vicki noted that the current budget provided by the Governor includes a tourism budget of \$18 Million, she also noted that based on the performance of the TMPF the UOT actually qualified for \$21 Million for 2016/2017 fiscal year.

## **ROAD HOME PRESENTATION:**

In the spirit of keeping our holiday tradition, we have continued our collection of blankets, hats, mittens, scarves and other warm items for donation to the Road Home homeless shelter. The Road Home provides support and shelter for overcoming homelessness by providing basic needs while connecting people with resources and helping to integrate them back into the community. The Road Home operates out of The Salt Lake Community Shelter, which is the largest homeless shelter in Utah. Chairman Rindlisbacher thanked everyone for their donations and invited Matt Minkevitch with the Road Home up to the podium to accept the contributions.
