

# **Dance/Live Entertainment Regulations**

The following outlines the regulations required for a dance, concert or other live entertainment at the Mountain America Expo Center:

## Age Limit

Attendees must be 18 years of age or older and must have a valid state or government ID.

#### **Dress Code**

- No lingerie, no beachwear. Shirts and shoes required.
- Licensee is responsible for enforcing dress code at the doors and throughout the event space.

#### Alcohol

Alcohol will be permitted to be sold by the Facility's exclusive caterer by means of a beer garden
concept only. This will mean that a beer garden may be set up in a separate, adjacent meeting
room space to the event. Access to the garden will be limited to only 21 years and older. Alcohol
will not be permitted to leave the "garden." Alcohol will be limited to beer sales.

## **Attendance Cap**

Event attendance will be capped contingent on the occupancy levels of the space contracted.

#### Hours

- Dance will not run past 1:00 a.m. on the day of the event.
- Ticket sales will cease at 11:59 p.m. on the day of the event.
- Attendees are not allowed "in and out" privileges. Anyone who leaves the building will not be allowed back in.

## Security, Police, Fire & Ambulance

- Mountain America Expo Center must approve Licensee's security company and plan. Staffing levels will be based on attendance anticipated, corresponding space required/used, unique circumstances created by acts hired and concurrent uses of the Mountain America Expo Center.
- Staffing levels must be finalized approximately 30 days out from the event following a site walkthrough with Promoter, Sandy Police Department, Sandy Fire Department, Salt Lake County Representative and Facility Management Representative.
- If the security company is hired by the Licensee themselves, security must provide event insurance



to specifications required by Facility Management. This will include a minimum level of general liability coverage and adding Salt Lake County, Sandy City and Facility Management as additional insured.

- Security company hired by Licensee must perform the following duties at a dance:
  - o Check IDs with ID card reader system (at Licensee's expense)
  - o Take tickets
  - o Perform pat downs
  - o Crowd control
  - o Staff a guard in each restroom
  - o Licensee must pay for security staffing in common areas throughout the facility that may be accessible to event attendees.
  - o Security personnel must be unarmed and highly visible.
  - Security personnel will be required to deny access to those individuals who appear under the influence of alcohol and/or illicit substances.
- Licensee will agree to Sandy City Police Department's recommendation for on-duty officers at the event.
- Licensee will pay for all Police officers required at the event. Licensee agrees that if additional officers are required at the event, it will be at the cost of the Licensee.
- Licensee will agree to Sandy City Fire Department's recommendation for paramedics and a "staged" ambulance(s) at the event.
- Licensee will pay for all Sandy Fire Department staff and equipment required at the event.
   Licensee agrees that if additional staffs are required at the event, it will be at cost to the Licensee.
- Facility Management will establish the occupancy for space rented based on square footage, available exiting, and the event outline.

## **Hydration Stations**

 Licensee will be required to provide, at their expense, portable hydration stations for the event attendees. The ratio of stations to attendees is established through the Salt Lake Valley Health Department (SLVHD). #### Rent

Rent will be established by the Mountain America Expo Center and based on published rates.



Estimated ancillary expenses will be included in the License Fee. The License Fee will be due in installments and 100% must be paid 30 days in advance of the event. Expenses not captured on the estimate will be billed and due at time of settlement (post- event).

 Ancillary expenses will be estimated by a Mountain America Expo Center event manager before event and actualized post event.

# Staging:

 Concert staging will be required for the main stage, including stage barricade, at expense of Licensee.

Licensee's compliance with these regulations is critical to life safety measures considered necessary by Mountain America Expo Center. Licensee's compliance will be considered at all times (pre-, during, and post-event). Licensee may be required during any of these times to modify their plan to maintain the highest level of safety standards possible. Licensee's continued use, during these times of the Mountain America Expo Center, will be based on their performance to these regulations, as well as a review of incidents at the event. The Mountain America Expo Center reserves the right to not book future dances in part or wholly based on a review of past events and in future consideration of the ability to host these events safely.
