#### **Public Relations**

Cruce reported on the efforts in Marketing and PR for June and July 2017. Marks and Cruce provided information on publicity received for June and July 2017 from assorted media (digital and print) sources handled by Pineapple PR.

#### **Sales Missions & Events**

Cruce and Metzler presented the Sales efforts which included e-mail., phone calls or in-person meetings by the Sales Team. Cruce also spoke about improvements in working to get more information into and from the Simpleview CRM.
