Frequently Asked Questions

What is Flint Promise?

Flint Promise is a commitment to offer scholarships and support services to students who both reside in the City of Flint and graduate from a high school or GED program located in the City of Flint.

What does the scholarship cover?

Flint Promise is a "last-dollar" scholarship, which means it covers the remaining balance of college tuition, books and mandatory fees after grants and other scholarships are received. The scholarship is pro-rated based on the number of years a student resides in Flint and attends an eligible high school. Through Flint Promise, students who qualify for a full scholarship will be able to attend college at no cost to them.

Note: GED graduates who live in the City of Flint and receive their GED from a City of Flint school are eligible to receive a Flint Promise scholarship covering 30 percent of remaining costs.

Who is eligible for a Flint Promise scholarship?

To apply for a Flint Promise scholarship, applicants must:

- Graduate from a high school located within the City of Flint, or receive a GED in the City of Flint, in or after 2018
- Reside within the City of Flint at the time of graduation
- Graduate with a 1.8 GPA or higher
- Complete the Free Application for Federal Student Aid (FASFA)
- Apply to a participating college or university
- Be age 24 or younger

To remain eligible for scholarship renewal, students are required to:

- Enroll in at least 24 credits per academic year
- Meet with their Success Coach on a regular basis
- Achieve minimum academic standards required for receiving financial aid, which include grade point average and successful completion of courses (credits attempted)
- Complete the FAFSA yearly

Is there a household income requirement?

No. Flint Promise scholarships are available to all students who meet the requirements listed above – regardless of household income.

Which high schools and GED programs are eligible in the city in Flint?

Where can the Flint Promise scholarship be used?

Currently, Flint Promise partners with Mott Community College and the University of Michigan-Flint, with plans to expand to other colleges and universities.

Flint Promise allows students to attend Mott Community College for up to three academic years as they pursue a certificate or an associate degree.

Once a Flint Promise student earns an associate degree or transfer certificate from Mott, the University of Michigan-Flint guarantees admission to transfer applicants. Also, the University of Michigan-Flint guarantees admission for first-time applicants from the Flint Promise district who meet the University's minimum admission requirements. There, the student may extend the Flint Promise scholarship for up to three additional academic years as he or she pursues a bachelor's degree.

I'm graduating high school with some college credits. How can I use the Flint Promise?

See below for the different options. Please note that this table assumes that all eligibility requirements have been met.

| Once an associate degree has been completed at Mott Community College, a student may use their Flint Promise scholarship toward a bachelor's degree at the University of Michigan-Flint. | *Students with 45 credits or more may begin pursuing a bachelor's degree at the University of Michigan-Flint immediately following high school. This will be evaluated on an individual basis and is contingent on the applicant meeting minimum admission requirements at the University of Michigan-Flint. | Once an associate degree has been completed at Mott Community College, a student may use their Flint Promise scholarship toward a bachelor's degree at the University of Michigan-Flint. |

Will summer courses be covered under the Flint Promise scholarship?

Yes, beginning in summer 2019.

What support services are provided?

Each Flint Promise student is paired with a Success Coach, who will provide academic and personal support throughout the student's college career.

How do I apply for Flint Promise? What are the deadlines?

The application process begins March 1, 2018. You may apply for Flint Promise online any time after that date. The deadline to apply for the Flint Promise scholarship for use during the fall 2018 semester is July 16, 2018 and November 15, 2018 for use during the winter 2019 semester. Applicants will be contacted by a Success Coach after applications are received.

Can I defer the scholarship? And, if so, for how long?

Yes. Applicants are eligible to apply for and use the Flint Promise program through the age of 24.
