PRIVACY POLICY

Garage Preneurs Internet Private Limited has created a web portal, an Android app and, an iOS app ("SlicePay," "we," "us," "our") aimed at providing credit facility for students in order to enable them to buy products online and services from designated online and offline merchants (this hereinafter referred to as "Services" and more clearly and elaborately defined in Terms of Service). This privacy policy ("Policy") discloses the practices and policies adopted by SlicePay for collecting, storing, retrieving or using personal information it may receive from its users ("you", "your") who access the Portal (defined below) to receive the Services. Services. ("**Personal Information**"). In general, SlicePay will use the information collected from you for the purposes for which you provided such information.

WHAT DO WE DO WITH YOUR INFORMATION?

Personal Information provided by you will be used by SlicePay only for the purposes of providing the Services and maintaining a confidential database. In addition to registration, Personal Information may be asked for reporting a problem/complaint with SlicePay. With your permission, we may send you emails about our Portal, new products, payment reminders and other updates. We may use the phone number provided and verified by you to reach out to you via call and sms. SlicePay will ensure that the Personal Information provided by you is treated securely, in accordance with the provisions of this Policy and the Rules. You are advised to refrain from posting personal information anywhere on the Website, other than those specifically required by SlicePay. The account information and profile are password protected. SlicePay will never ask for your password through unsolicited phone calls, emails. However, if any person, claiming to be an authorized representative of SlicePay, contacts you, we request you not to provide any information to such person and instead immediately contact SlicePay as per the contact details provided in this Policy. SlicePay shall not be liable for any loss of Personal Information provided to such persons.

SlicePay may also be required to share the Personal Information with its third party contractors who provide SlicePay with back end data operation services.
