


Figure 1. AWP Form

WHEREFORE; on motion of Honorable Michael Ladaona, Chairperson on Disaster was duly seconded by the August body present be it...


RESOLVED as it is hereby resolved, to approve the annual work program for the year 2020 of barangay Dulao, lagawe, Ifugao;

WHEREAS; when project is made possible it will be of help to the constituents of the barangay to ferry victims of minor accidents, and other victims of any disaster that it may come along the way;




