**“RESOLUTION REQUESTING SN ABOITIZ POWER MAGAT, INC. THROUGH ITS PRESIDENT AND CEO JOSEPH S. YU TO UTILIZE THE AMOUNT OF SIX HUNDRED FORTY-EIGHT THOUSAND ONE HUNDRED EIGHTY-SEVEN PESOS AND THIRTY-ONE CENTAVOS (PHP 648,187.31) FOR COVID-19”**

**WHEREAS**, on 16 March 2020, the President issued Proclamation No. 929, declaring a State of Calamity throughout the Philippine Due to the COVID19 and placing the entire Luzon on the Enhanced Community Quarantine (ECQ);

**WHEREAS**, the Local Government Unit requested the Department of Energy thru channels available funds under its ER 1-94 to augment our funds to combat the spread of COVID-19;

**WHEREAS**, in order to address the priority needs of the frontliners and health workers, these funds shall be utilized for the procurement of relief goods, PPE's and medical supplies;

**NOW THEREFORE**, and upon motion of Hon. Jaime H. Dog-e, duly seconded, be it;

**RESOLVED** as it is hereby resolved to request the SN Aboitiz Power Magat, Inc. through its President and CEO Joseph S. Yu to utilize the amount of Six Hundred Forty-Eight Thousand One Hundred Eighty-Seven Pesos and Thirty-One Centavos (Php 648,187.31) for Covid-19;

**RESOLVED FINALLY**, to forward this resolution to the SN Aboitiz Power Magat, Inc. through the its President and CEO Joseph S. Yu and all offices concerned for their information and basis of action.




