


Figure 1. AWP Form

CUSI, DEPARTMENT OF ENERGY, TAGUIG CITY, METRO MANILA THROUGH MR. JOSEPH S. YU, PRESIDENT AND CHIEF EXECUTIVE OFFICER, S/N ABOITIZ POWER MAGAT, INCORPORATION, BARANGAY AGUINALDO, RAMON, ISABELA**

**WHEREAS**, the Sangguniang Bayan Office receives a communication from the Local Chief Executive (**LCE**) requesting the **AUGUST BODY** to adopt resolution for the approval and endorsement of the Annual Work Financial Plan (**AWP**) for 2020 of the Municipal Local Government Unit of Lagawe, Ifugao pertaining to the amount of Six Hundred Forty-Eight Thousand One Hundred Eighty-Seven Pesos and Thirty-One Centavos (₱648,187.31) only, intended for and/or in response to COVID-19 Public Health Emergency to be funded by the Department of Energy (**DOE**);

**WHEREAS**, with the immediate deliberation on the urgent request of the **Local Chief Executive** in the Sangguniang plenary, the Annual Work Program for the year 2020 of MLGU-Lagawe is a paper requirement set by the **Department of Energy and S/N Aboitiz** for the utilization of the share of MLGU-Lagawe from the Department of Energy (**DOE**) under Energy Regulations 1-94 (ER 1-94);




