

## EC Declaration of Conformity

## Declaration about Environmental-related Hazardous Substances according to the EU Directives RoHS

Neutrik AG declares that not any of the following restricted or banned substances are used in the manufacture of parts and devices of its connector products:

- Lead (Pb) ≤ 1000 ppm (0.1 %)
- Mercury (Hg) ≤ 1000 ppm (0.1 %)
- Cadmium (Cd) ≤ 100 ppm (0.01 %)
- Hexavalent chromium (Cr6+) ≤ 1000 ppm (0.1 %)
- Polybrominated biphenyls (PBB) ≤ 1000 ppm (0.1 %)
- Polybrominated diphenyl ethers (PBDE) ≤ 1000 ppm (0.1 %)
- Bis(2-Ethylhexyl) phthalate (DEHP) ≤ 1000 ppm (0.1 %)
- Benzyl butyl phthalate (BBP) ≤ 1000 ppm (0.1 %)
- Dibutyl phthalate (DBP) ≤ 1000 ppm (0.1 %)
- Diisobutyl phthalate (DIBP) ≤ 1000 ppm (0.1 %)

However, some products may contain lead (Pb) subject to 2011/65/EU Annex III exemption, namely:

6 (a) Lead as an alloying element in steel for machining purposes and in galvanised steel containing up to 0,35 % lead by weight.

6 (c) Copper alloy containing up to 4 % lead by weight.

Any of the above substances present would have to be described as an impurity and would only be present below the allowable concentration value tresholds.

This declaration conforms to following Regulations, Directives and Rules:

- Directive 2011/65/EU of 8 June 2011 (2002/95/EC and successive amendments recast)
- Commission Delegated Directive (EU) 2015/863 of 31 March 2015 amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances.

## **RoHS3 Conformity Declaration**

With the latest updates from the modification of Annex 2 of the **RoHS** legislation, the list of prohibited substances is increased by inserting 4 phthalates.

With the update Reg. (EU) 2018/35 entered into force on 27 June 2018, 10 new dangerous substances were added. Only two of these are inherent in cable construction. All our raw materials have been verified and therefore we can say that:

Hydrogenated terphenyl - CAS 61788-32-7 (<0.1%) Dicicyclohexyl phthalate - CAS 84-61-7 (<0.1%)

The restriction on DEHB BBP, DBP and DIBP does not apply to cables or spare parts intended for repair, reuse or upgrading of functionalities or capacity of EEE marketed before 22 July 2019.
