

## Competition Terms & Conditions – Golden Ticket 2026/27

1. This prize draw (“**Prize Draw**”) is open to all UK residents aged 18 or over. Anyone aged under the age of 18 years old at the date of entry shall be automatically disqualified.

8. The Promoter reserves the right to screen entrants against our internal fan behaviour records and to select an alternative winner where an entrant is found to have received any disciplinary sanction issued by the Promoter or has any conviction relating to behaviour at St Mary’s Stadium.
9. The Promoter accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be entered for any other reason.
10. Entrants who enter the Prize Draw shall be deemed to have accepted these Terms and Conditions.

The Promoter, acting in its sole discretion, reserves the right at any time to modify or discontinue, either temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated, suspected or actual fraud). The decision of the Promoter in all matters under its control is final and binding and no correspondence will be entered into.

The Promoter will contact the winners personally using the email address provided in their entry to the Prize Draw. 17. If a winner rejects their Prize or the entry is invalid or in breach of these Terms and Conditions, the winner’s Prize will be forfeited, and the Promoter shall be entitled (but not required) to select another winner at random.
