You may **CANCEL** this contract at any time until **TEN (10) DAYS** after you receive a copy of this contract. You do not need a reason to cancel.

If you do not receive the goods or services within **SEVEN (7) DAYS** after the agreed delivery date, you will be notified of any delay. If the order does not arrive within **TWENTY-ONE (21) DAYS** of the agreed delivery date, you may cancel the order. You may cancel this contract within one year of the contract date. You lose that right if you accept delivery after the **TWENTY-ONE (21) DAYS**. There are other grounds for extended cancellation. For more information, you may contact your state/territorial consumer affairs office.

If you cancel this contract, the seller has **FIFTEEN (15) DAYS** to refund your money and any trade-in or the cash value of the trade-in. You must then return the goods.
