Live proctors appointed by Talend ("Proctors") will be overseeing the Exam remotely or in person. Your Exam provider is Kryterion ("Provider"). Please contact your Provider for any questions regarding the Exam.

By purchasing or using any Talend exam certification or credential products or services ("Exam Services"), and as a condition to your continued use of the Exam Services, you hereby agree to be bound by the terms of use in the Exam Agreement. If you do not agree to all of the terms, you may not access or use the Exam Services.

We reserve the right to change or modify the Exam Agreement at any time and in our sole discretion. If we make changes, we will provide notice of such changes by posting the revised Exam Agreement to the Talend website and/or by sending an email notification or posting additional notice on the Talend website. Your continued use of the Exam Services following our notice of the amended Exam Agreement will confirm your acceptance of the amended terms. If you do not agree to the amended terms, you may not continue accessing or using the Exam Services.

Any breach by you of the terms in this Exam Agreement may result in termination of your use of the Exam Services, loss of your credential certification and/or denial of your ability to use any of the Exam Services in the future.
