



# Talend Cookie Notice

This Cookie Policy explains how Talend and its group companies (collectively “Talend”, “we”, “us”, and “ours”) use cookies and similar technologies to recognise you when you visit our websites at Talend.com and services (“Websites”). It explains what these technologies are and why we use them, as well as your rights to control our use of them.

## What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Cookies are widely used by website owners in order to make their websites work, or to work more efficiently, as well as to provide reporting information.

Cookies set by the website owner (in this case, Talend) are called “first party cookies”. Cookies set by parties, other than the website owner, are called “third party cookies”. Third party cookies enable third party features or functionality to be provided on or through the website (e.g. like advertising, interactive content and analytics). The parties that set these third party cookies can recognise your computer both when it visits the website in question and also when it visits certain other websites.

## Why do we use cookies?

We use third party cookies for several reasons. Some cookies are required for technical reasons in order for our Websites to operate, and we refer to these as “essential” or “strictly necessary” cookies. Other cookies also enable us to track and target the interests of our users to enhance the experience on our Websites. Third parties serve cookies through our Websites for analytics and other purposes. This is described in more detail below.

### **Strictly necessary cookies**

These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. Required cookies are essential to operate the Services, there is no option to opt out of these cookies.

### **Functionality Cookies**

These cookies enable the website to provide enhanced functionality and personalisation. They may be set by us or by third party providers whose services we have added to our pages. If you do not allow these cookies then some or all of these services may not function properly. These cookies may not be disabled without affecting the functioning of the Websites.

### **Performance Cookies**



These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our site, and will not be able to monitor its performance.

### **Marketing Cookies**

These cookies collect information for analytics and to personalize your experience with targeted ads. You may exercise your right to opt out of the sale of personal information by using this toggle switch. If you opt out we will not be able to offer you personalised ads and will not hand over your personal information to any third parties.

## **How can I control cookies?**

You have the right to decide whether to accept or reject cookies non-essential to the functioning of the Websites by unselecting the cookie type and “Confirming My Choices” button on the Talend website cookie banner.

In certain regions, you can also set or amend your web browser controls to accept or refuse cookies. If you choose to reject cookies, you may still use our website though your access to some functionality and areas of our website may be restricted. As the means by which you can refuse cookies through your web browser controls vary from browser-to-browser, you should visit your browser’s help menu for more information.

## **Cookies and CCPA compliance at Talend**

Talend does not sell information as the term “sell” is traditionally used. However, to the extent “sale” under the CCPA is interpreted to include advertising technology activities, such as those disclosed in the Analytics and Advertising and Managing Cookies sections of the [Talend Group Privacy Notice](#), as a “sale,” we will comply with applicable law as to such activity.

Within the last 12 months, we may have “sold” or “shared” information within each of the following categories:  
Personal Information:

- Identifiers like email address, IP address, cookies, and other user tracking information.
- Internet or Other Network Activity.
- Geolocation data.
- Professional or employment-related information.
- Inferences about your preferences.

Sensitive Personal Information: None.

California residents have a right to opt-out from the “sale” or “sharing” of their personal information with third parties who are not Talend “service providers” (as those these terms are defined in the CCPA). If you are a California resident, we monitor and respond to do not track signals for targeted advertising you may have set up in your browser.
