IN CONSIDERATION of the mutual promises and covenants set out herein and for other good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged), including the opportunities outlined in the Creative Invite, Licensor grants to Producer, its successors, assigns and licensees an exclusive, irrevocable license to incorporate, use, reproduce, edit, or alter the artwork depicting the 60's style advertisement inspired by the *Mad Men* Soundtrack as described in the Creative Invite, which is based on and/or inspired by the television series *Mad Men* (the "Artwork"), in whole or in part, in connection with the promotion and exploitation of the Property in any manner and in all media, whether now known or hereinafter devised, in all territories throughout the world, in perpetuity without further notice to, consent by, or payment to Licensor. Nothing herein shall obligate Producer to use the Artwork in or in connection with the Property.

Licensor represents and warrants that: (i) Licensor has obtained any and all required authorizations, releases, consents, clearances and licenses from any third parties as may be necessary with respect to Producer's use of the Artwork as herein contemplated, and has paid any fees and other payments required in connection therewith, (ii) Licensor has the authority to grant to Producer the right to use the Artwork as contemplated in this License, (iii) Licensor has fully agreed to the terms of and has the capacity and every right to execute this License, and (iv) such use by Producer will not violate or infringe upon the rights of any third party, whether personal or proprietary. Licensor agrees to indemnify and hold Producer and its successors, assigns and licensees, harmless from and against any and all claims, actions, damages, liabilities, costs and expenses (including without limitation, attorneys' fees and costs) arising out of or in connection with a breach of the foregoing representations and warranties. Licensor hereby agrees that in no event shall Licensor be entitled to injunctive or equitable relief in connection with a breach of this Artwork License ("License") and that Licensor's rights and remedies shall be limited to the right, if any, to obtain monetary damages at law. Licensor further forever waives any right to terminate this License or to otherwise interfere with the use and enjoyment of the rights granted in this License.

This License is binding upon and shall inure to the benefit of the respective successors and/or assigns of the parties hereto. This License sets forth the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, representation and warranties, both oral and written, if any, made with respect to the subject matter hereof. This License may not be modified, amended, terminated or discharged unless confirmed in writing by all parties hereto. This License shall be construed in all respects in accordance with the laws of the State of California. The rights herein granted shall endure for the periods of all copyrights and other rights in and to the Artwork, and for any and all renewals or extensions thereof that Licensor may now own or control without Producer or any third parties having to pay additional consideration.

Licensor hereby waives in favor of Producer and its successors, assigns and licensees all moral rights of whatsoever nature in and to the Artwork.
