# Who is CAUDIT?

The Council of Australasian University Directors of Information Technology (CAUDIT) is the peak body for ICT in the Higher Education and Research sector. CAUDIT brings together University and Research Institutions from across Australasia. Members include all public universities in Australia and New Zealand along with those of Papua New Guinea and Fiji plus key national research institutions in Australia.

Beginning with some formality in 1976 (and informally 10 years prior to that), CAUDIT has been an incorporated not-for-profit association since 2010 and is owned, funded and directed by its Members. Member Representatives are the most senior person leading IT in their institution i.e. the CIO, CDO or IT Director of each member institution.

CAUDIT's purpose is to support each other in leading the application of digital capabilities to transform education and research. CAUDIT supports Member Representatives and their teams through the provision of a broad range of services that foster collaboration, leadership and good practice among Members. Three strategies provide the focus for CAUDIT's activities: connecting, enabling and challenging our members.

# Procurement

Leveraging collective buying power to derive maximum mutual value

CAUDIT negotiates with ICT vendors on a sector-wide basis to derive maximum mutual value and ensure that staff from member institutions have a good understanding of current vendor offerings to CAUDIT members.

### Benefits of CAUDIT's Strategic Procurement activities:



### Cost Reduction

A reduction in the cost to do business including sector savings in procurement staff resources; these cost savings should be evident for both CAUDIT Members and the vendor.



### Demand Aggregation

An improved ability for CAUDIT to aggregate demand for product and services via term, group or volume purchasing commitments. This also leads to greater leverage in the marketplace to influence product development and direction.



### Standardisation

Improved coordination between the CAUDIT membership with respect to the product and services being used in order to simplify the service and technology mix in use within CAUDIT Members and support processes within and between CAUDIT Members.



### Simplified Processes

A reduction in the bureaucracy required to engage with vendors, including (but not limited to) common terms and conditions, a single price list and improved handling of procurement processes.



### Information Sharing

Improved communication between vendors and the CAUDIT Membership including technology roadmaps, support and process information and general communications.

### Benchmarking

CAUDIT's benchmarking data offers trusted, confidential reference points that support Member Representatives to plan for and maintain high performance returns from IT capabilities and assets within their organisations. Annually since 2003, CAUDIT Members submit information into the CAUDIT Benchmarking System to produce the Annual CAUDIT Benchmarking Report and provide direct access to the data with the Online Access Data Service. Access is available to CAUDIT CIOs/IT Directors and to their authorised staff members with the data usage governed by an Acceptable Use Policy.



### Top Ten Topics

The annual Top Ten Topics report presents the most significant technologyrelated topics for higher education in Australia and New Zealand. The topic ranking emerges from analysis of survey returns from CAUDIT Member Representatives. Each year the survey is modified to incorporate the changing profile of technology-related priorities across the sector.



### Surveys

Information from CAUDIT colleagues on any issue can be obtained using the CAUDIT Survey Service. On request, CAUDIT facilitates the collection of survey data on behalf of the initiating institution. The resulting feedback and analysis is not only useful to the initiating survey institute, but more often than not also to the sector more broadly.



# **CAUDIT Complexity Index**

CAUDIT pioneered the concept of the Complexity Index to enable meaningful benchmark comparisons across its membership and ultimately with other national higher education sectors. It is based on four key measures, namely: Number of students (EFTSL), Number of staff (FTE), Research income (\$), Number and size of different university sites serviced by IT

# Capability

### CAUDIT Leadership Institute (CLI)

The CAUDIT Leadership Institute is an immersive one-week residential program designed to enhance the leadership skills of Australian and New Zealand information technology and information resources managers in higher education. The Institute has been offered annually since 1998 and is an excellent program for driven individuals who aspire to be influential modern day leaders.



### CAUDIT Managers Program (CMP)

Over seven months the CAUDIT Managers Program gives middle managers the skills and tools they need manage teams and stakeholder relationships.

The CAUDIT Managers Program offers training and coaching modules including 360-degree feedback using the LSI model (Leadership Skills Inventory). The program is capped at 20 participants each year to ensure maximum personalised interaction between participants and session facilitators.



### Communities of Practice (CoPs)

CAUDIT Communities enable sector-wide exploration of, and response to, unexpected change and long-term challenges. CoP Members benefit from interactive forums and enduring professional networks, both of which are avenues for formal and informal professional development.



### Short Courses

CAUDIT delivers a range of topical workshops throughout the year that focus on developing critical skills of staff working in IT in Higher Education and Research.

### **AHECS**






