Discussion of Alternative Agenda presented by Ray Bowers – copy shared with Board only.

Discussion of Executive Session to discuss covenants, proposed 2019 budget and road reserve and open Treasurer position.

<u>Motion by Ray Bowers, second by Fran Berg</u>, to go into Executive Session to discuss covenants, proposed 2019 budget and road reserve and open Treasurer position. Approved unanimously.

Discussion of High Speed Internet Proposals:

• Town of Mountain Village Fiber Optic proposal promises 1GB upload and download speeds. Estimated costs at approximately \$800,000 with installation starting in 2019 – completion 2020. If cost distributed equally

per lot at approximately \$3339.18 for installation, plus fees per household: \$250 equipment for wireless or wired.

- Proposal includes boring versus shallow trenching conduit.
- Approximate monthly service fees per residence = \$75 (internet) and cable \$60 (TV) per month per house. Detail attached.
  - Guest houses if rented then you'll want to make separate
     if guest use only could connect to main house
- Commitment needed by April/May to get in Phase 3 schedule.
- 100% buy-in required
- DOLA grant application deadline in February might be available to HOA.
- ClearNetwork Each lot \$10,000 cost plus \$40/ft to lay conduit, Only requires 50% buy-in. Sliding scale plans available.
- Brainstorm Wireless does not recommend wireless due to mountain forest topography

Discussion of Town of Mountain Village water improvements starting in 2019 that are expected to lower Ski Ranches homeowners fire insurance due to improved flow.

- Changing name from Road Reserve to simply Reserve Fund. Approved unanimously.
- \$50,000 assessment to go into Operation Budget under asphalt.
   Approved unanimously.

Discussion of change over to new Administrative Assistant (AA) for 2019. Present AA agreed to deliver all materials to Board Secretary Greg Malver on 12/13/18 if replacement is not found by then. Once new AA is hired then old AA agreed to spend up to two hours to brief new AA. All email, website, domain name, and other items (such as misc. picnic supplies, board book, etc) will remain the property of TSRA.
