

"3, 2, 1 SKI!" Contest Rules

1. CONTEST DURATION

The contest will take place on the Outaouais Tourism web platform.

1. Webpage location and contest dates: https://www.tourismeoutaouais.com/en/contest/ (contest name: "1, 2, 3, SKI"). Contest opens at midnight (0:00) on October 15, 2018, and closes at 23:59 on November 15, 2018.

2. ELIGIBILITY

On the **cross-country ski contest page** at <u>www.outaouaistourism.com</u>, the contest is open to anyone 18 years old or older who **completes the contest entry form**.

The following are NOT eligible to enter:

Employees, agents and/or representatives of Outaouais Tourism and of any suppliers of services and prizes, advertising agencies or any entity or person connected to this contest, as well as any person with whom such an employee, agent and/or representative resides or any member of his immediate family. IF YOU ARE NOT ELIGIBLE, PLEASE DO NOT ENTER THE CONTEST.

3. **HOW TO ENTER**

1. For a chance to win, visitors who click on the "Enter the Contest" link in the "3,2,1, SKI" contest section of the website www.outaouaistourism.com must select the ski event* in which they want to participate, and complete the Outaouais Tourism contest entry form.

*Note that a participant can fill out two contest entry forms, one for each cross-country ski event—namely, the *Canadian Ski Marathon (CSM)* and the *Gatineau Loppet*. However, a participant who wins the contest for one event will automatically be disqualified from the contest for the second event.

4. PRIZE DESCRIPTION

Among all the entries received in accordance with the contest rules, one (1) winning entry will be drawn at random from the entries for the *Canadian Ski Marathon*, and one (1) winning entry will be drawn at random from the entries for the *Gatineau Loppet*.

Prize description, Canadian Ski Marathon (CSM):

Two (2) CSM registrations (winner's choice); two (2) nights' accommodation at the Fairmont Le Château Montebello (double occupancy), *Saturday, February 8* and *Sunday, February 9, 2019*; two (2)early-bird buffet breakfast at Aux Chantignoles restaurant, from 3:30 a.m. on Saturday and 4 a.m. on Sunday; two (2) buffet dinner at Aux Chantignoles, from 5:30 p.m. for two; room service from 6 a.m. to 11 p.m.; 10% discount on selected massages at the Spa Fairmont Le Château Montebello. Alcohol not included.

Shuttle service available from the hotel to the CSM site. A waxing area will be available in the Heritage Room near the hotel.

Prize value: \$1,500 + tax.

Prize description, Gatineau Loppet:

Two (2) Gatineau Loppet registrations (winner's choice); two (2) nights' accommodation at the Ramada Plaza Manoir du Casino (double occupancy), *Saturday, February 15 and Sunday, February 16, 2019*; two breakfasts and two dinners for two at Bistro 75. Alcohol not included.

Prize value: \$1,286 + tax.

Prizes are valid only for the 2019 edition of the cross-country ski events specified above.



5. **DRAW**

The names of the winners will be drawn at random from among all entries received in accordance with the contest rules, at 12 noon on Friday, November 16, 2018, at the Outaouais Tourism offices (103 Laurier Street, Gatineau, Quebec).

In the event that the winner is not eligible for the prize, that person will be disqualified, and a new winner will be chosen at random.

6. **NOTIFICATION OF WINNER**

The contest winners will be notified by email shortly after the draw. The winners' names will also be posted in the "3, 2, 1, SKI" contest section of the Outaouais Tourism website.

7. ACCEPTANCE OF THE PRIZE

The prize must be accepted as awarded. It may not be exchanged in whole or in part for cash. It may not be substituted for another prize, except at the sole discretion of the contest organizers, who reserve the right to replace one or several elements of the prize package with other elements of equal or greater value. The prize may not be transferred to another person. Refusal to accept the prize by the selected person releases contest organizers from any and all obligations regarding the awarding of the prize. Contest winners must claim their prize within fifteen (15) days of the date of the prize draw, failing which Outaouais Tourism reserves the right to select a new winner at random.

8. PUBLICITY

To be declared the winner, the selected entrant must authorize the organizers and their representatives to use his or her name, photograph, likeness, voice, place of residence and prize statement for advertising purposes, if required, without any form of remuneration.

9. OTHER CONDITIONS

- 1. All contest entrants agree to be bound by the official contest rules. Failure to comply with the official contest rules will result in disqualification. All entrants also agree to be bound by the decisions of Outaouais Tourism, which will be final and without appeal and will be enforced in all respects.
- 2. To be declared the winner, the selected entrant must sign a form acknowledging receipt (declaration and waiver) releasing Outaouais Tourism and all persons or companies connected to this contest from all liability for any damage that may arise from the acceptance and/or use of the prize. The form will be forwarded to the selected entrant, who must return it within seven (7) business days following its receipt, failing which he will be automatically disqualified, and another draw will be held, in keeping with these contest rules, until another entrant is selected and declared the winner.
- 3. The selected entrant must provide proof of age to the contest organizers, if required, and confirm in writing having complied with the official contest rules, failing which he or she will be disqualified, and another draw will be held, in keeping with these contest rules, until another entrant is selected and declared the winner.
- 4. In the event that the contest organizers are unable to award the prize for reasons of force majeure that are beyond their control and unrelated to the winner, they undertake to submit to the winner a prize of equivalent value and type or, at the organizers' sole discretion, the value of the prize in cash.
- 5. This contest is subject to all applicable federal, provincial, state and municipal laws.
- 6. For the purposes of these rules and regulations, the entrant is the physical person holding the account corresponding to the email address given on the entry form.
- 7. Entrants undertake not to deliberately interrupt or corrupt the holding of the contest, cause damage to the website, prevent others from participating in the contest, or in any other way contravene these rules, failing which the entrant will be automatically disqualified and liable to be prosecuted under any recourse available to the contest organizers.



- 8. The contest organizers release themselves from any liability for the malfunction of any computer component, software or communication line, relative to the loss or absence of network communication, or relative to any transmission that is faulty, incomplete or incomprehensible, or erased by any computer or network or server, and which could limit the possibility of, or prevent, any person from participating in the contest. The contest organizers disclaim any responsibility for any damage or loss that may be caused, directly or indirectly, in whole or in part, by the downloading of any software and the transmission of any information connected to participation in the contest.
- 9. The contest organizers release themselves from any liability with regard to the availability or non-availability of certain categories or events of either or both of the cross-country ski events specified above (CSM and Gatineau Loppet).
- 10. The contest organizers reserve the right, at their sole discretion, to cancel, end, modify or suspend the contest in its entirety in the event that a virus, computer bug, unauthorized human intervention or any other cause beyond the control of the organizers may corrupt or affect the administration, security, impartiality or normal running of the contest, subject to the approval of the Régie des alcools, des courses et des jeux du Québec (for residents of Quebec).
- 11. It is strictly forbidden to use or reproduce any material protected by copyright and trademark related to this contest without the written consent of the rights-holder.

10. **DISPUTES**

For residents of Quebec: Any dispute regarding the organization or conduct of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux du Québec for a ruling. Any disagreement regarding the awarding of a prize may be submitted to the Régie only for the purpose of an intervention to attempt to resolve such disagreement.

In case of any discrepancy between the French and English versions of these rules, the French version shall prevail.
