

### Terms of Use

Welcome, and thank you for your interest in Slash Eureka, Inc., doing business as Ascend ("**Ascend**," "**we**," or "**us**") and our website at <u>www.useascend.com</u> (the "**Site**"). These Terms of Use are a legally binding contract between you and Ascend regarding your use of the Site. Please read the following terms carefully before using the Site. *By using the Site, you acknowledge that you have read, understood, and agree to be bound by the following terms and conditions, including the <u>Ascend Privacy Policy</u> (together, the "Terms"). If you are not eligible, or you do not agree to the Terms, then you do not have our permission to use the Site.*

# Restrictions
