

TEAM TRAVEL POLICY

REQUIREMENTS

Minor Athlete Abuse Prevention Policies MUST be followed while at a hotel of a sanctioned NGB/HPMO/USOPC event/competition.



ALL MEETINGS NEED TO BE OBSERVABLE AND INTERRUPTIBLE



ALL MASSAGES NEED TO BE OPEN AND INTERRUPTIBLE WITH 2 ADULTS PRESENT

REQUIRED CONSENT FORMS

TRAVEL TO A COMPETITION

When ONE Applicable Adult and ONE minor athlete travels to an event/competition a written consent form MUST be obtained from a parent/legal guardian by the Applicable Adult prior to traveling with the minor athlete.

HOTEL STAYS

When an Applicable Adult is sharing a hotel room or other sleeping arrangement with an unrelated minor athlete, a written consent form MUST be obtained from a parent/legal guardian by the Applicable Adult prior to sharing a hotel room with that minor athlete.

Review the consent and only complete the areas of the form that are necessary and that you agree to by initialing that area and signing the form at the bottom.

Please note depending on the policy, consent could be required:

- 1 | Every instance,
- 2 On an annual basis, or
- 3 | The parent/guardian can determine if the consent is provided every instance or annually.

If an option is not provided for annual consent, then consent needs to be provided in every instance. Additionally, consent can be withdrawn by a parent/guardian at any time.
