Village of Lisle Scholarship Program Information Sheet

Scholarship Amount: \$5,000

### Objective:

To provide tuition assistance to students who seek to enroll at Universal Technical Institute located in Lisle, Illinois. This scholarship program is aimed at students who reflect a true commitment to converting their talents working with their hands into a career as a professional technician in the transportation industry.

### Criteria for awarding the scholarship:

This scholarship program is available to all students who currently reside in the Village of Lisle. All applicants must meet all other admissions requirements for Universal Technical Institute, in addition to all of the criteria outlined below to be eligible to apply.

### Eligibility Criteria:

- Students must be enrolled to start Universal Technical Institute located in Lisle, Illinois.
- Eligible applicants must be able to show proof that they are a resident of the Village of Lisle.
- Redeem scholarship and start classes at Universal Technical Institute, Lisle IL by May 31, 2025.
- Students receiving the following scholarships are not eligible to receive the Village of Lisle Scholarship:
  - Lisle Community School District 202 Scholarship
  - Naperville Community Unit School District 203 Scholarship

If applicant is a recipient of any of the programs listed above at the time of application review, the Village of Lisle Scholarship application will be deemed ineligible.

### Process and Rules:

This scholarship program is available starting January 15, 2024, through May 1, 2024. Students must complete an application and submit it to the UTI Scholarship Department. **This scholarship is ONLY available to incoming students who reside in the Village of Lisle. Students already attending classes at UTI are ineligible to apply.** All applications are due to the Scholarship Department no later than **May 1, 2024**. All eligible applications will be reviewed by the UTI Scholarship Committee, and up to two eligible applicants will be awarded no later than **May 13, 2024**.

Of those viable applications, the awards will be distributed to those students who most clearly and adequately answer the essay question provided: **“What/who inspired you to seek a career in the automotive, diesel, motorcycle, marine, marine, welding, energy, or robotics industry? How will attending Universal Technical Institute help you to achieve your goals of a career in this industry?”** Students must be enrolled to attend Universal Technical Institute located in Lisle, Illinois at the time of the application submission. Scholarships awarded are not transferable to any other person. This scholarship is considered an internal tuition reduction and has no cash value. All internal tuition reductions are pro-rated over the time a student is in school. If a student chooses not to attend UTI prior to the deadline or, after beginning his/her program chooses to leave for any reason (withdrawal, suspended, terminated), they will forfeit any unused portion of the award. All scholarships granted through this program can only be used during the initial enrollment; any unutilized funds cannot be applied to a secondary account/enrollment. Only one award of this scholarship will be given per student. The applications received will be reviewed for completeness and accuracy of all information provided. Students who apply and meet all requirements will be considered for this scholarship.
