## Objection form

In accordance with Article L. 324-8-2 of the French Intellectual Property Code, non-ADAGP member authors can request, at any time, that their works be excluded from the scope of extended collective licensing contracts administered by ADAGP.

- for living authors: a copy of an identity document;
- for authors' rights holders (heirs or legatees): a copy of an identity document, a copy of the notarial deed(s) ("acte(s) de notoriété") establishing your status as the author's rights holder;
- for the exclusive assignees of copyright in an author's works: a copy of the exclusive copyright assignment, a copy of an identity document if the assignee is a natural person, or a certificate of incorporation ("extrait Kbis") if the assignee is a legal entity.
