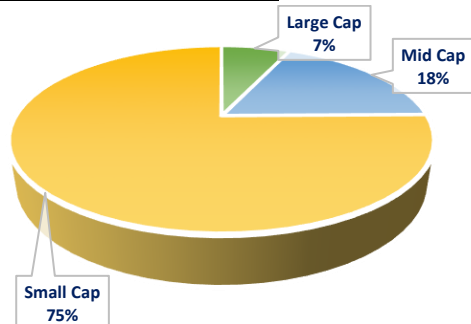

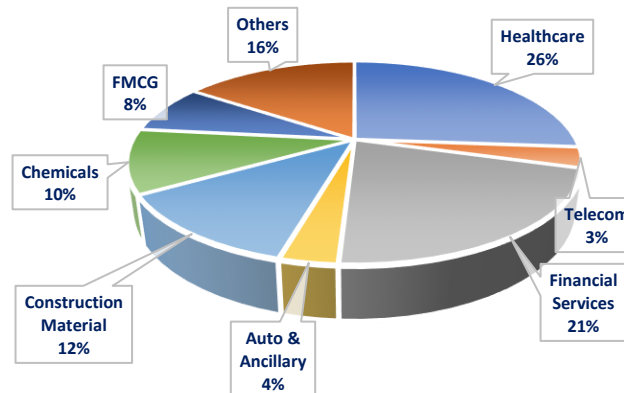
Market Capitalization⁴

Performance and Market Review

The portfolio was up 1.6% in July 2026, underperforming the S&P BSE 500 TRI Index benchmark by 0.6%. The allocation to small-cap increased by 102 bps as compared to 30th June 2026, while allocation to mid-cap increased by 99 bps. The allocation to Healthcare & Auto decreased by 447 bps & 178 bps respectively as compared to 30th June 2026, while allocation to FMCG increased by 78 bps.

In July 2026, S&P BSE 500 TRI index was up 2.1% on the m-o-m basis. The Large & Mid Cap were up by 2.3% & 1.6% respectively in July 2026 while Small Cap was up by 1.1%.

Sector-wise, IT & Auto Healthcare were up by 16.8% & 8.6% respectively while Energy & PSU Banks were down by 2.5% & 1.5% respectively in July 2026.
