



LEVITON WARRANTY 5-YEAR LIMITED WARRANTY FOR INDOOR LED FIXTURES, INCLUDING ENERGY STAR[®] LED FIXTURES

Leviton warrants to its customer and the original end user the LED electronics and components of its properly installed LED products, to be free of defects in material and workmanship, in normal use, for a period of five (5) years from the date of shipment by Leviton and warrants the painted finish for a period of one (1) year from the date of shipment by Leviton. The painted finish of the product will be considered defective in material or workmanship only if there is substantial deterioration in the form of blistering, cracking, or peeling within the one (1) year warranty period. The painted finish is not warranted against fading or chalking, as it may naturally fade or chalk over time due to normal aging.

Leviton, at its sole option, will repair, replace, credit or refund, any warranted product returned to it that it determines to be defective. The customer or the consumer must return the product, transportation prepaid, to Leviton at 725 Landwehr Road, Northbrook, IL 60062 within the warranty period. No return of products will be accepted without a Return Goods Authorization ("RGA") which may be obtained by calling 847-559-5550. This warranty excludes and there is disclaimed liability for labor for removal of this product or reinstallation of this product or a replacement product. In addition to complete failure, defects include lumen depreciation to levels below 70% of initial lumen output within warranty period and/or color shift beyond that which is set forth in the current Energy Star Program Requirements for SSL within warranty period.

This warranty is void if the product is installed in violation of the National Electrical Code, or any applicable local electrical codes, or in an improper environment, misused, opened, abused, or altered in any manner or is not used under normal operating conditions or not in accordance with any labels or instructions. This warranty does not cover damages due to environmental conditions, acts of nature, animal or insect activity, or power surges.

THE REMEDIES PROVIDED HEREIN ARE THE EXCLUSIVE REMEDIES UNDER THIS WARRANTY, WHETHER ARISING OUT OF CONTRACT, TORT, STRICT LIABILITY, OR OTHERWISE.
