Vitreous China

- Gerber Plumbing Fixtures ("Gerber") warrants to the original consumer purchaser that the vitreous china of toilets and sinks will be free from defects in material and workmanship under intended use for as long as the original consumer purchaser owns it (limited lifetime warranty). For commercial installations, this coverage is for five (5) years.

Components & Parts

- Gerber warrants to the original consumer purchaser of Viper®, Avalanche®, and decorative toilets* that the components included with the original purchase will be free from defects in material and workmanship under intended use for fifteen (15) years. For commercial installations, this coverage is for one (1) year.
- Gerber warrants to the original consumer purchaser of Ultra Flush® toilets that the components included with the original purchase will be free from defects in material and workmanship under intended use for ten (10) years. For commercial installations, this coverage is for one (1) year.
- Gerber warrants to the original consumer purchaser of Avalanche Select™, Maxwell®, Maxwell Choice™, Maxwell Crest™, Maxwell Select™, Sedria™, Viper Edge™, Viper Force™, Viper Select™ toilets that the components included with the original purchase will be free from defects in material and workmanship under intended use for five (5) years. For commercial installations, this coverage is for one (1) year.
- Gerber warrants to the original consumer purchaser of Banner™ toilets that the components included with the original purchase will be free from defects in material and workmanship under intended use for two (2) years. For commercial installations, this coverage is for one (1) year.
- Gerber warrants to the original consumer purchaser of Maxwell SE toilets that the components included with the original purchase will be free from defects in material and workmanship under intended use for one (1) year.
- Gerber warrants to the original consumer purchaser of toilet seats that the seats will be free from defects in material and workmanship under intended use for one (1) year.
- Gerber warrants to the original consumer purchaser of all other toilets/collections and parts & components not mentioned above will be free from defects in material and workmanship under intended use for five (5) years. For commercial installations, this coverage is for one (1) year.

Gerber will not be liable for any labor, freight, shipping, or any other costs or charges incurred in connection with removal or replacement of the product or otherwise acting on the above warranties, or for repair or replacement of any personal property, building or installation materials.

Gerber will not be liable for incidental or consequential damages resulting from installation or use of the product not in accordance with the product instructions; reasonable wear and tear; misuse, abuse or neglect of or accident to the product; or moving the product from its original installation location.

Use of cleaning solvents/chemicals or cleaning methods including in-tank bowl cleaners will void the above warranties. Gerber will also not be liable for any damage to, or failure of, tank components or vitreous chinaware caused by chloramines or a high concentration of chlorine, lime/iron sediments, or other minerals not removed from the public water supply during the treatment of public water supply.

This warranty does not apply to local building code compliance. Since local building codes vary considerably, the purchaser of the product should check with a local building or plumbing contractor to ensure local code compliance before installation.
