

## Epic Night with Stewart Copeland Official Contest Rules

2: CONTEST SCHEDULE: This Contest commences at 10:00 a.m. Mountain Time on April 12, 2019 10:00 a.m. Mountain Time and closes on May 17, 2019 at 10:00 a.m. Mountain Time (the "**Entry Period**"). Entry forms must be received before the contest closing time to be eligible for the draw (the "**Draw Closing Time**"). The draw for weekly prizes will commence on their corresponding draw dates at 4:00 p.m. Mountain Time. The draw for the Grand Prize will take place on May 17, 2019 at 4:00 p.m. Mountain Time.
