

Win Your Purchase Official Contest Rules

1: SPONSOR: Win Your Purchase (the "**Contest**") is conducted and sponsored by the Winspear Centre and Edmonton Symphony Orchestra (ESO) (herein referred to as the "**Sponsors**").

2: CONTEST SCHEDULE: This Contest commences on August 1, 2019 at 10:00 A.M. Mountain Time and closes on August 31, 2019 at 11:59 P.M. Mountain Time (the "**Entry Period**"). Entry forms must be received before the contest closing time to be eligible for the draw (the "**Draw Closing Time**"). For Edmonton Symphony Orchestra OC, subscribers and donors, the Contest includes Edmonton Symphony Orchestra single tickets purchased starting on July 19, 2019 at 10:00 A.M. until August 31, 2019 at 11:59 P.M.

3: NOTIFICATION: The Sponsor will contact the winner (the "**Selected Entrant**") by email or phone (depending on the means the Entry was received) within one (1) business day of the selection for the Prize. If the Selected Entrant does not contact the Sponsor by 4:00 P.M. Mountain Time four (4) business days after, the applicable Prize will be forfeited and Sponsor will contact, as replacement only, an alternate Entry.
